**Tip:** Keep copies of your letters and s69 approval certificate or send via email to keep a time dated paper trail of correspondence.

**Remember:** your employer must grant your request to attend on pay as long as you provide them with at least 14 days' notice. (Section 69(d)(ii) of the OHS Act 2004)
